
# GOVERNMENT RESOLUTION 550: PROGRESS REPORT (2022)

IATF SUMMARY

On August 16, 2023, the Authority for the Economic Development of the Minority Sectors within the Ministry of Social Equality released <u>an extensive report</u> outlining the primary measures taken to close economic gaps in Arab society, as well as the key accomplishments over the first year of implementation of GR-550 across various domains. The report also presents insights and recommendations for ongoing implementation.

This update is a summary of the data shared in Ministry of Social Equality report, including discussion of overall progress and details per main area of investment, as illustrated in the chart below from main development areas' reports.

# Budget Allocation per Five Main Areas in 2022. Total of NIS 5.9 B



**GR-550:** In October 2020, the government of Israel approved the GR-550 five-year plan (2022-2026) for the economic advancement of the minority sector, with the goal of integrating Arab society into the Israeli economy. The plan, which received a budget of 30 billion NIS for five years, aimed to allocate 21.8 billion NIS to the Arab and Bedouin societies in the north, 5.2 billion NIS to the Bedouin society in the south, and 3 billion NIS to the Druze and Circassian society. The implementation involved collaboration with over 30 ministries and government entities.

According to the report, around 5.9 billion NIS of the five-year plan's budget was directed to Arab society in the preceding year.



#### **Main Goals**



- Reduce the dropout rates by at least 50%.
- Reduce the gap in the number of eligible individuals for matriculation exams between Arab and Bedouin secular education and Jewish secular education by at least 50% in comparison to the previous year.
- Increase the proportion of graduates who pass the Yael test with a score of 80-90.
- Increase the number of graduating high school students taking matriculation exams by at least 50% in comparison to the previous year.
- Increase the number scores eligible for higher education to 64%.

Efforts to close educational gaps are the second largest part of the GR-550 core budget and the focus of the NIS 4.3 billion in differential budgeting across various projects. These initiatives included the construction of 505 new classrooms, efforts to narrow the gaps in matriculation eligibility rates, the development of a comprehensive plan to enhance the performance of education departments in Arab authorities, and the strategic placement of native-speaking teachers in 70 middle schools situated in Arab localities.

The data reveals substantial socio-economic disparities between Arab society and the broader Israeli community, resulting in high poverty rates and increased reliance on welfare services. The funding aims to advance efforts in narrowing the gaps in welfare services within Arab society, offering a comprehensive range of welfare and social resources. The focus lies on addressing the specific challenges unique to Arab society, alongside adapting and refining existing programs as needed.

# **Sport and Culture: Sport**

One of the key factors leading to a shortage of Arab athletes in competitive and team sports is the disparity in sports infrastructure between Arab and Jewish communities. This infrastructure gap creates a barrier to the inclusion of new athletes from the Arab community. This section proposes, among other things, the enhancement of physical infrastructure in program communities, the encouragement of youth engagement in sports within the Arab community, and the training of professionals, such as coaches, to attain high-level competencies.

#### **Main Goals:**



- Enhancing sports facilities by constructing, renovating, and developing accessible venues for the community.
- Increasing community participation in sports and physical activities, emphasizing equitable access to sporting opportunities.
- Establishing and reinforcing the infrastructure of multidisciplinary sports clubs within Arab society.

### **Progress**



Construction of new pools in Baka Algrabia and Sahnin, along with the construction of a new stadium in Kfar Qasim. Additionally, the upgrading of stadiums in the cities of Sakhnin and Umm Alfam, as well as the construction of sports halls and numerous sports facilities in various Arab localities.

# **Sport and Culture: Culture**

**Purpose:** There are significant disparities in both infrastructure and cultural activities within the Arab community, both in terms of per capita investment and the extent of the activity. Activities under this section are aimed at establishing culture as an integral component in the daily life of Arab society, including bolstering cultural organizations across various fields, promoting efforts to address physical infrastructure challenges for cultural activities, and eliminating barriers that hinder relevant entities.






# **INFRASTRUCTURE**



# Infrastructure

In line with the plan, the majority of the GR-550 budget allocations was directed towards infrastructure.

#### Budget allocation per area in 2022 out of a total of NIS 2,265



A comprehensive strategic plan has been completed for all 133 settlements within the minority sectors, focusing on enhancing the urban road network. With a budget of 1.02 billion NIS, projects are now underway, with 98 active at varying stages. Over the past year, the needs of Arab communities to be connected by urban roads were carefully outlined as part of the five-year plan for Routes of Israel. A budget of approximately NIS 100 million was allocated for this purpose, driving the advancement of 29 ongoing projects.

An additional allocation of around NIS 150 million has been committed to the advancement of the Tira train station, currently in the construction phase and projected to be completed by the end of 2023. Furthermore, approximately NIS 75.2 million has been set aside to bolster public transportation by introducing new routes and modifying existing ones. A tailored strategy has also been devised to curtail the occurrence of road accidents within the Arab society, with a dedicated budget of NIS 26 million.

Around NIS 150 million was directed to improve public facilities and communal spaces like parks and gardens. Additionally, barriers for public marketing of housing units were removed, leading to a visible uptick in marketing efforts in 2022 compared to prior years. Further investments included approximately 180 million NIS to enhance water and sewage infrastructure, 30 million NIS for establishing renewable energy systems and fostering energy conservation in Arab communities. Moreover, roughly 185 million NIS were dedicated to streamlining waste collection systems in Arab communities.

# Sewage



Government Authorities: Governmental Water and Sewage Authority

Total Budgeted: NIS 635 M | NIS 300 M in differential budgeting

2022 Allocations: NIS 188 M

#### Main Goals:

- Sewage infrastructure: a substantial increase in connected households.
- Aiming for a 90% sewage system connection rate in minority communities and municipalities within the Water and Sewage Corporation's jurisdiction.

### **Progress**



Allocating budget to multiple projects aimed at addressing wastewater and sewage management in minority communities, which includes funding for treatment plants, local solutions, and connecting households and neighborhoods to the sewage system. This initiative has led to a rise from 80% to 85% of homes being connected to sewage systems.

# **Transportation**



Government Authorities: Ministry of Transportation and Road Safety, he National Road Safety Authority, Ayalon Highways Company, Israel Roads Company.

Total Budgeted: NIS 1.57 B | NIS 1.25 B in differential budgeting

**2022 Allocated:** NIS 1,954 M

#### **Main Goals**



- Create and implement a strategic plan for all minority communities, prioritizing key areas based on criteria like economic development and housing, tailored to each community's size.
- A 9% decrease in the number of severe or fatal cases within the Arab community compared to the annual average between 2016 and 2020.
- Boosting the use of public transportation and expanding the network of public transit routes.

# **Progress**



Roads: The strategic plan for all 133 minority communities has been finalized. Each community has identified and prioritized the projects to be undertaken. As of the end of 2022, there are currently 98 active projects in various stages: 10 have been completed, 45 are in progress, and 43 are in the planning phase.

Enhancing public transportation by introducing additional services and route outlets.

The requirements for inter-city roads are being actively addressed as part of the comprehensive five-year plan by the Israel Roads Company. Presently, there are 29 projects underway in this initiative, with 7 already in execution and 22 in the planning stages.

Budget: NIS 150 M



A targeted plan was developed to reduce road accidents involving members of the Arab community in Tamra, Shefa-'Amr, A'ablin, Umm al-Fahm, Bir al-Maksur, Basmat Tab'un, and Kafr Qabul. This includes a pilot program and focused efforts on road safety.

### **Tourism**



**Government Authorities:** Ministry of Tourism

Total Budgeted: NIS 7 M | NIS 7 M in differential budgeting

2022 Allocated: NIS 8 M

#### Main Goals:

- Increasing the availability of lodging units in high-demand tourist regions.
- Improving the maintenance and sanitary standards of primary tourist destinations.



Following Government Resolution 550, the Authority for Economic Development promoted the decision for the development of Jisr az-Zarqa. The Resolution, developed collaboratively with relevant government ministries, was approved on July 18, 2022. The program has a budget of approx. NIS 200 M, included in GR 550 and additional budgets. It focuses on municipal capacity building, social gap reduction (with emphasis on welfare, education, and health), infrastructure development, and growth engines (including housing and tourism). It also prioritizes personal security. With government approval, the Authority established an implementation team to create a detailed work plan in collaboration with government ministries and the local authority.

Despite recent plans to improve environmental conditions in Arab communities, particularly regarding waste management, a gap persists in environmental quality and services compared to the majority population in Israel. #### **Government Resolution 1834**



On August 17, 2022, GR 1834 was approved, with a budget of approx. NIS 300 M. The decision followed extensive groundwork, including the compilation of current data, survey of needs from various local authorities, consultations with relevant civil society organizations and stakeholders, and intensive work by dedicated teams. The decision's focus areas include youth, employment, welfare, life skills education, culture, and sports. The work plans of the relevant ministries were approved by the dedicated committee responsible for GR 550, which also oversees the implementation of this resolution.

#### **Government Resolution 1849**



On September 2, 2022, the GR 1849 was put into effect. This plan instructs relevant ministries and authorities, including the Authority for Economic Development, to adopt and act upon the recommendations developed within the framework of the team that examined the barriers facing Arab businesses. These recommendations aim to improve their access to government procurement, as well as procurement within government-owned companies and public corporations.

A marketing campaign was prepared to promote and facilitate registration in the Yahalom - Government Procurement system, which is expected to launch soon. The campaign's goal is to encourage business owners and service providers to register and gain access to government tenders available to registered vendors.
